

# Wild Scoops Job Description: Delivery & Logistics Lead, 2026



Wild Scoops is a vibrant company that brings incredible ice cream to Anchorage while spreading joy and building community. We make all our own ice cream and specialize in local and adventurous flavors.

The Delivery & Logistics Lead has the principal responsibility of keeping the Scoop Shops fully stocked with ice cream, specialty products, and supplies. They are responsible for understanding the needs of the shop, anticipating future needs and delivering product and materials before they are needed on-site. They load, transport and deliver products in a safe, timely manner with the Wild Scoops van. They also assist with other routine pick-ups and deliveries.

We're looking for a dependable, detail-oriented driver with a can-do attitude and a willingness to dive right in. If you communicate well with others and also enjoy working alone, take pride in an efficient system and a job done well, this might be a good fit.

The Delivery & Logistics Lead (DL Lead) position may either be:

- a) Part-time (~20 hrs/ week) and seasonal (start now through early April, work through at least Sept 14). The specific summer requirements are ~3-4 hours a day, 5 days a week (including some weekends), primarily between the hours of 7-10 a.m
- b) Full-time and seasonal or year-round, when combined with a Production or Scoop Team job (see separate posting). 40 hrs/week in the summer and 15-40 hrs/week in the off-season (as desired). Shifts approx 7:00-4p, 5 days a week.

There is one Delivery & Logistics Lead and 1-2 support drivers.

## **Expeditor Accountability:**

1. Communicating with the Shop and Production Managers as needed to coordinate successfully between available product and shop requirements.
2. Communicating with the other Delivery & Logistics team members to problem-solve and ensure systems are working smoothly with all expeditors. Identifying team needs and proactively addressing.
3. Training other Delivery & Logistics team members according to best practices, supporting them and providing timely feedback.
4. Reading inventory program spreadsheets and internal calendars to assess each location's ice cream needs.
5. Documenting flow of product accurately and according to current protocols.
6. Loading the company van and transporting ice cream from the Test Kitchen to the Scoop Shops, following company food safety, sanitation and driving safety guidelines with high attention to detail. Bringing dishes back from Scoop Shop to Kitchen.

7. Unloading ice cream and stocking freezers according to best food safety and quality practices and to optimize space.
8. Practicing FIFO (First In, First Out) inventory management protocols consistently; leading other team members in understanding and implementing FIFO as needed.
9. Performing all other deliveries and errands as needed
10. Maintaining the company van, logging miles and damages, cleaning and sanitizing the interior, keeping the exterior bright and representing the company well, driving at least once weekly during winter, and coordinating scheduled maintenance.
11. Problem-solving and trouble-shooting to help everything run smoothly — identifying challenges, brainstorming solutions and presenting ideas to the leadership team.
12. Acting with great professionalism, security-mindedness and positivity.
13. Consistently reflecting on personal practice — recognizing strengths and areas to grow.
14. Coordinate with the appropriate manager(s) to create a Delivery and Logistics staff schedule to ensure appropriate coverage of all operational duties.
15. Attending monthly meetings to discuss the current status of the Delivery and Logistics' teams needs and abilities.
16. Having ultimate accountability for the transfer of products between locations in a timely and safe manner.

**The ideal candidate will:**

- Have a valid driver's license and clean driving record (required).
- Be available mornings (7am) and weekends.
- Be extremely organized and detail-oriented with outstanding time-management skills.
- Have experience working with inventory or warehouse management, or developing/refining systems to maximize efficiency.
- Have the ability to drive van safely in a variety of weather and traffic conditions
- Have a reputation for excellent interpersonal and communication skills.
- Have a track record of dependability, responsibility and integrity.
- Be able to effectively manage emotions and stress in the workplace.
